## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, hand finished raised, 9ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.18mm width (at base) x 1.03mm depth, with curved underrail, open back underneath.

Feature; "cluster style" ring design, with shoulder stones. Comprising, a raised square shaped, four claw setting, houses four round brilliant cut diamonds illusion claw set. The extended shoulders, of the band, tapers up to the top. Each shoulder contains six round brilliant cut diamond, channel set.



Polished finish, stamped "375, P\*"- acid tested as 9 carat gold.

Finger size = L.

The ring contains;

Four illusion claw set round brilliant cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.25mm (average diameter) x 1.37mm (D-estimated)

Total Weight = 0.16ct (estimated - see NOTE below).

Twelve channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.49mm (average diameter) x 0.91mm (D-estimated)

Total Weight = 0.14ct (estimated - see NOTE below).

### Item Totals

Total Item Weight = 2.95 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 2.89 grams (estimated)

NOTE: Limited germological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
