Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 14ct yellow gold & diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures 1.92mm width (at base) x 1.07mm depth, with curved underrail.

Feature, "solitiare style" ring design. Comprising, a raised, white gold four claw setting to centre. Houses one Princess cut (laser inscribed & certified), claw set. The extended shoulders, of the band tapers up wide with a channel centre, filled with nugget type peices, to both sides.

Polished finish, stamped "14K NOC" - acid tested as 14 carat gold.

Finger size = K1/2.

The ring contains;

One claw set princess cut diamond, clarity is "Vs2", colour is "E", very good/good cut quality.

Dimensions = 4.34mm (L) x 4.21mm (W) x 3.09mm (D-estimated) x 5%(Girdle Thickness)

Total Weight = 0.50ct (known - see NOTE below).

Total Item Weight = 3.20 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 3.10 grams (estimated)

NOTE: The Princess cut diamond, has been certified by, and is the opinion of, Messrs. Gemological Institute of America, Certificate no.5182463005. Dated MAY, 31, 2017. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 5182463005. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
