Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, flat, tapered band of 3.26mm width (at base) x 0.86mm depth, with open back settings.

Feature central vertical row of alternating, two square cut natural rubies, with one round brilliant cut diamond in the centre, channel set. The settings are secured between the shoulders of the plain and polished band. The shoulders are embellished with a 'fluted' pattern.



Polished finish. Stamped '375' - acid tested as 9 carat gold. Ring size: T 1/2.

The ring contains:

One channel set round brilliant cut diamond, clarity is "Si1", colour is "I".

Dimensions = 2.65mm(Dia) x 1.62mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.07ct (estimated - see NOTE below)

Two channel set square natural rubies, colour is "red".

Dimensions (average) = 2.64mm(L) x 2.64mm(W) x 1.61mm(D-estimated)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 6.42 grams Total Gemstone Weight = 0.27ct Total Metal Weight = 6.37 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
