Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and rhodium plated, diamond set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.10mm width (at base) x 1.23mm depth, with a hollow top and shoulders, open back settings, and a curved cut out underrail.

Feature three horizontal rows of thirteen round brilliant cut diamonds, spanning across the top of the band. The diamonds graduate in size, largest to the centre, and are claw set. The settings are secured between the shoulders of the plain and polished band. Rhodium plating to the setting areas.

Polished finish.

Stamped '14KT 1.00' - acid tested as 14 carat gold.

Ring size: P 1/2.

The ring contains:

Thirty Nine claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to I" (mixed).

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.32mm(Dia) x 1.42mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 7.22 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 7.02 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
