
Valuation for Traditional Retail Insurance Replacement

Item 1

One, pair of lady's hand-assembled, 10ct white gold & diamond set, hoop earrings.

Feature, medium sized hoop style earrings, both with curved post, hinged clip fittings to base, attached. Each hoop, having a single claw set row to front, housing, thirty four round brilliant cut diamonds, claw set. Plain to back.

Polished finish, stamped "10K, MHJ" - acid tested approximately 10 carat gold. Earring dimensions = 40.00mm (Diameter) x 2.00mm (width) x 1.91mm (depth).



The earrings contain:

Sixty Eight claw set round brilliant cut diamonds, clarity is "Si, P1, P2 & P3" (mixed), colour is "H to J" (mixed), medium cut quality.

Dimensions = 1.48mm (average diameter) x 0.92mm (D-estimated) (smallest)

Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (largest)

Total Weight = 1.00ct (estimated - see NOTE below).

Total Item Weight = 7.68 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 7.48 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of hoop earrings, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
