## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 18ct white gold, cluster, style, gem set, dress ring.

Plain, narrow band of 2.04mm in width (at base) x 1.11mm depth, with open back centre setting.

Feature central four claw setting, housing one oval cut and faceted natural aquamarine, claw set. Surrounded by twenty-six round brilliant cut diamonds (smallest), also claw set. Secured between the shoulders of the plain and polished band. Each shoulder having six round brilliant cut diamonds, tapering in size to largest, claw set.



Polished finish - stamped '18K 750 diamond symbol in circle 1.40ct' - acid tested. Finger size is L 1/2.

The ring contains:

One claw set mixed cut oval shape natural aquamarine, colour 'medium light blue'.

Dimensions = 8.79mm(L) x 6.38mm(W) x 4.60mm(D-estimated)

Total Weight = 1.40ct (estimated - see NOTE below)

Thirty Eight claw set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.60ct (estimated - see NOTE below)

Total Item Weight = 3.80 grams - Total Gemstone Weight = 2.00ct - Total Metal Weight = 3.40 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
