Valuation for Traditional Retail Insurance Replacement

One, 18ct yellow gold and rhodium plated, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.72mm width (at base) x 0.98mm depth, with open back settings, and a curved underrail.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The settings is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band. Rhodium plating to the central setting.



Polished finish.

Stamped '750 15 A&C' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "H".

Dimensions = 4.39mm(L) x 4.35mm(W) x 2.65mm(D-estimated) x 1%(Girdle Thickness)

Total Weight = 0.31ct (estimated - see NOTE below)

Total Item Weight = 3.31 grams Total Gemstone Weight = 0.31ct Total Metal Weight = 3.25 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
