One, 18ct yellow gold and 9ct white gold, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 2.29mm width (at base) x 1.01mm depth, with a curved underrail.

Feature railed white gold six claw setting, housing one round brilliant cut diamond, claw set. The settings is securd to the underrail, and in between the extended and pointed shoulders, of the plain and and polished yellow gold band.



Polished finish.

Stamped 'DL 750 .60(engraved)' - acid tested as 18 and 9 carat gold.

Ring size: M 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "G".

Dimensions = 5.43mm(L) x 5.41mm(W) x 3.15mm(D-estimated) x 6%(Girdle Thickness)

Total Weight = 0.60ct (estimated - see NOTE below)

Total Item Weight = 3.31 grams
Total Gemstone Weight = 0.60ct
Total Metal Weight = 3.19 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting.
