## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.20mm width (at base) x 1.16mm depth, with open back settings, and a curved underrail.

Feature central bezel setting, housing one emerald cut diamond, bezel set. Surrounding is one row of twenty round brilliant cut diamonds, bead set. The top plate is secured to the underrail, and in between the upswept and square shoulders, of the plain and polished band. Each of the shoulders houses one row of six round brilliant cut diamonds, bead set.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One bezel set emerald cut diamond, clarity is "P1", colour is "J".

Dimensions = 5.38mm(L) x 5.02mm(W) x 4.25mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.96ct (estimated - see NOTE below)

Thirty Two claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to K" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.28ct (estimated - see NOTE below)

Total Item Weight = 3.25 grams Total Gemstone Weight = 1.24ct Total Metal Weight = 3.00 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
