Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.19mm width (at base) x 1.37mm depth, with open back settings, and a curved underrail.

Feature central three claw setting, housing one pear shaped laboratory grown synthetic diamond, claw set. Surrounding is one row of eighteen round brilliant cut, laboratory grown synthetic diamonds, claw set. The top plate is supported with an open pierced decorative gallery, and is secured to the underrail, and in between the extended and tapering shoulders of the plain and polished band.

Polished finish.

Stamped 'Meera 18K LGD 1.23 CT 0383' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

- One claw set pear shaped diamond, clarity is "Vs2", colour is "E".
Dimensions = 8.53mm(L) x 5.52mm(W) x 3.5mm(D-estimated) x 4%(Girdle Thickness)
Total Weight = 1.00ct (known weight - see NOTE below)
- Eighteen claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G+".
Dimensions (average) = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.23ct (estimated - see NOTE below)

Total Item Weight = 4.92 grams Total Gemstone Weight = 1.23ct Total Metal Weight = 4.67 grams (estimated)

NOTE: The diamond has been certified by and is the opinion of Messrs. International Gemological Institute, Certificate no. LG442060383 Dated 9/22/2020. The diamond has also been laser inscribed upon the girdle with IGI (logo) and LABGROWN IGI LG442060383. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
