Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.04mm width (at base) x 0.97mm depth, with a hollow top and shoulders, and open back (cut out) settings.

Feature central square top plate within a four claw setting, housing four Princess cut diamonds, invisibly set. The setting is secured between the extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of four Princess cut diamonds, channel set.

Polished finish.

Stamped '375 GM16' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 2.32mm(L) x 2.32mm(W) x 1.65mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.32ct (estimated - see NOTE below)

Eight channel set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "J".

Dimensions (average) = 1.60mm(L) x 1.60mm(W) x 1.14mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 2.33 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 2.23 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
