## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 14ct yellow gold, dress style, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.66mm in width (at base) x 0.90mm depth, with hollow top and shoulders, and open back settings.

Feature central three claw setting, housing one pear-shape natural sapphire, claw set. Surrounded by twenty-one round brilliant cut diamonds (largest), claw set. All secured between the extended shoulders of the plain and polished band. Each split shoulder having thirty-six round brilliant cut diamonds (smallest), also claw set.



Polished finish - stamped '585 S1.00ct D0.30ct' - acid tested as 14 carat gold. Finger) size is N.

The ring contains:

One claw set mixed cut pear-shape natural sapphire, colour 'medium dark blue'.

Dimensions = 7.58mm(L) x 5.91mm(W) x 2.73mm(D-estimated)

Total Weight = 1.00ct (estimated - see NOTE below)

Fifty Seven claw set round brilliant cut diamonds, clarity 'P2 to P3' (mixed), colour 'G to I' (mixed).

Dimensions = 0.90mm(Dia) x 0.65mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.25mm(Dia) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 2.36 grams - Total Gemstone Weight = 1.30ct - Total Metal Weight = 2.10 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
