## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 14ct rose gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.01mm in width (at base) x 1.03mm depth, with a split and curved underrail.

Feature multi-claw ring design, housing five round cut and faceted natural rubies, claw set. Alternating with eight round brilliant cut diamonds, also claw set in groups of two. All secured between the shoulders of the plain and polished band.



Polished finish - stamped '14K 585 RU0.84 D0.09' - acid tested as 14 carat gold. Finger size is

The ring contains:

Five claw set round cut and faceted natural rubies, colour 'medium dark red'.

Dimensions = 3.40mm(Dia) x 2.07mm(D-estimated) (smallest)

Dimensions = 3.80mm(Dia) x 2.32mm(D-estimated) (largest)

Total Weight = 0.84ct (estimated - see NOTE below)

Eight claw set round brilliant cut diamonds, clarity 'P2 & P3' (mixed), colour 'I to J' (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.09ct (estimated - see NOTE below)

Total Item Weight = 2.51 grams - Total Gemstone Weight = 0.93ct - Total Metal Weight = 2.32 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The rubies are heavily included. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
