Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.33mm in width (at base) x 1.30mm depth, with open back (cutout) shoulder settings.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. Secured between the 'ramp' style shoulders of the plain and polished band. Each shoulder having five round brilliant cut diamonds, tapering in size, channel set.



Polished finish - stamped '18ct' - acid tested as 18 carat gold. Finger size is N.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P1', colour 'H'.

Dimensions = 4.35mm(Dia) x 2.65mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.31ct (estimated - see NOTE below)

Ten channel set round brilliant cut diamonds, clarity 'Si', colour 'G to H' (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.11ct (estimated - see NOTE below)

Total Item Weight = 4.31 grams - Total Gemstone Weight = 0.42ct - Total Metal Weight = 4.23 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
