Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, cluster style, gem set, dress ring, of cast construction.

Plain, narrow, tapered band of 0.99mm in width (at base) x 0.82mm depth, with open back (drilled) shoulder settings.

Feature central six claw railed, 'cluster' style setting, housing seven round brilliant cut diamonds, largest sunken set to the centre, surrounded by six round brilliant cut diamonds, claw set. Secured to the top of the plain and polished band, each shoulder having two round brilliant cut diamonds, largest, channel set.



Polished finish - stamped '375' - acid tested as 9 carat gold. Finger size is J.

The ring contains:

One sunken set round brilliant cut diamond, clarity 'P1', colour 'G'.

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.025ct (estimated - see NOTE below)

Ten claw set & channel set (mixed) round brilliant cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'G to H' (mixed).

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.135ct (estimated - see NOTE below)

Total Item Weight = 1.63 grams - Total Gemstone Weight = 0.16ct - Total Metal Weight = 1.60 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
