Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct white gold, cluster style, gem set, dress ring, of cast construction.

Plain, narrow, tapered band of 2.20mm in width (at base) x 1.21mm depth, with open back settings, and hollow shoulders.

Feature central four claw setting, housing one oval cut and faceted natural sapphire, claw set. Surrounded by sixteen round brilliant cut diamonds (smallest), claw set, with decorative pierced wire sides. All secured between the 'ramp' style shoulders of the plain and polished band. Each shoulder having five round brilliant cut diamonds (largest), claw set.



Polished finish - stamped '10KT MHJ' - acid tested as approximately 10 carat gold. Finger size is O.

The ring contains:

One claw set mixed cut oval shape natural sapphire, colour 'dark blue'.

Dimensions = 6.80mm(L) x 5.25mm(W) x 2.48mm(D-estimated)

Total Weight = 0.74ct (estimated - see NOTE below)

Twenty Six claw set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'H'.

Dimensions = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.47ct (estimated - see NOTE below)

Total Item Weight = 3.30 grams - Total Gemstone Weight = 1.21ct - Total Metal Weight = 3.05 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
