Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, flexible link necklet, of hand-assembled construction.

Feature one cultured pearl, with a scalloped edge white gold finding, end set. To the top of the pearl is one articulated four claw setting, housing one round brilliant cut diamond, claw set. The pendant is finished with a tapered bail. The pendant is suspended on a filed oval style link chain that can be adjusted, and is finished with a lobster style clasp.

Chain dimensions = 47.00cm (ave. length) x 0.17mm (ave. width).

Pendant dimensions = 24.00mm (ave. length) x 11.08mm (ave. width) x 11.06mm (ave. depth).

Polished finish.

Stamped 375 375 ITALY S' - acid tested as 9 carat gold.

The pendant contains:

One end-drilled round cultured pearl, colour is "black".

Dimensions = 11.08mm(L) x 11.06mm(W)

One claw set round brilliant cut diamond, clarity is "Si2", colour is "H".

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.02ct (estimated - see NOTE below)

Total Item Weight = 4.41 grams

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
