Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and rhodium plated, multistone, gem set ring, of cast construction.

Plain, wide, tapered band of 14.55mm at top to 3.99mm in width (at base) x 1.14mm depth, with hollow top and shoulders, open back settings, and a pierced 'lattice' style design underrail.

Feature central setting section having twelve round brilliant cut diamonds, largest slightly tapering, in a 'grid' style design, bead set. Surrounded by twenty-six round brilliant cut diamonds, also tapering in size to smallest in four row sections, bead set. The shoulders having a rippled design, rhodium plated to the centre and setting area.

Polished finish.

Unstamped - acid tested as approximately 14 carat gold.

Finger size is R 1/2.

The ring contains:

Thirty Eight bead set round brilliant cut diamonds, clarity 'P2 & P3' (mixed), colour 'G to H' (mixed).

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.33mm(Dia) x 1.42mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 9.28 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 9.08 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
