Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and 9ct yellow gold and rhodium plated,, gem set, 'cluster' style pendant, of hand-assembled construction.

Feature 'flower' style cluster, housing seven round brilliant diamonds, largest to the centre, invisibly and claw set. The pendant is finished with a fixed tapered bail. Rhodium plating to the setting areas.

Pendant dimensions = 13.80mm (ave. length) x 6.80mm (ave. width) x 4.00mm (ave. depth).

Polished finish. Stamped '375 14K aG' - acid tested as 14 and 9 carat gold.

The pendant contains:

One invisibly set round brilliant cut diamond, clarity is "P2", colour is "G".

Dimensions = 2.90mm(Dia) x 1.77mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below)

Six claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 0.82 grams Total Gemstone Weight = 0.40ct Total Metal Weight = 0.74 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
