### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's hand-assembled raised, 14ct yellow & white gold & gemset, drop style pendant.

Feature, open cluster style drop pendant. Comprising, an articulated rub-over white gold setting, to centre, houses one round brilliant cut diamond, rub-over set. An open circular shaped surround, with a fixed v-shaped bail attached to top, contains a total of twenty round brilliant cut diamonds, claw set.

Polished finish, stamped "14K MHJ 0.50 TDW" - acid tested as 14 carat gold.

Pendant dimensions = 16.97mm (total length inclusive) x 10.71mm (width) x 5.05mm (depth).

The pendant contains:

One rub-over set round brilliant cut diamond, clarity is "P1", colour is "H/I"(inset), medium cut quality.

Dimensions = 3.70mm (average diameter) x 2.29mm (D-estimated)

Total Weight = 0.20ct (estimated - see NOTE below).

Twenty claw set round brilliant cut diamonds, clarity is "P3", colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.30mm (average diameter) x 0.79mm (D-estimated) (smallest)

Dimensions = 1.47mm (average diameter) x 0.90mm (D-estimated) (largest)

Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 1.40 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 1.30 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
