Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, knife edge band of 2.29mm width (at base) x 1.40mm depth, with open back settings, and a curved underrail.

Feature round white gold top plate, within a six claw setting, housing eleven round brilliant cut diamonds. The largest of the diamonds to the centre, small and medium alternating to the edges, invisibly and claw set. The setting is secured to the underrail, and in between the shoulders of the plain and polished yellow gold band.

Polished finish. Stamped '375 JP02' - acid tested as 9 carat gold. Ring size: O.

The ring contains:

Six invisibly and claw set round brilliant cut diamonds, clarity is "Si2 & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 2.80mm(Dia) x 1.71mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.90mm(Dia) x 1.77mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.46ct (estimated - see NOTE below)

Five claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 4.14 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 4.04 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
