Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 9ct yellow gold & gemset, multistone ring. Plain, wide, half round, tapered band, measures 3.72mm width (at base) x 1.20mm depth, with curved underrail, open back settings, underneath.

Feature, "scatter style" ring design. Comprising, a raised wide rounded band to top, houses sixteen round brilliant cut diamonds, scattered formation, across the top, rub-over set, flush to the band. The extended shoulders, of the plain band, tapers up wide to the top, from both sides.

Polished finish, stamped "375" - acid tested as 9 carat gold.

Finger size = K.

The ring contains;

- Sixteen rub-over set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "G to I"(mixed), medium cut quality.
- Dimensions = 1.55mm (average diameter) x 0.95mm (D-estimated) (smallest)
- Dimensions = 2.42mm (average diameter) x 1.48mm (D-estimated) (largest)
- Total Weight = 0.45ct (estimated - see NOTE below).

Total Item Weight = 5.28 grams, Total Gemstone Weight = 0.45ct, Total Metal Weight = 5.19 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
