## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct white gold, gem set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.30mm width (at base) x 1.03mm depth, with a hollow top and shoulders, open back settings and a cut out curved underrail.

Feature square top plate, within a four claw setting, housing nine Princess cut diamonds, invisibly set. The setting is secured to the decorative underrail, and in between the tapering shoulders, of the plain and polished band. The gallery is embellished with two round brilliant cut diamonds, bezel set.



Polished finish.

Stamped '18K 750 is' - acid tested as 18 carat gold.

Ring size: O 1/2.

The ring contains:

Nine invisibly set Princess cut diamonds, clarity is "Si & P1" (mixed), colour is "G".

Dimensions (average) = 2.10mm(L) x 2.10mm(W) x 1.49mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.54ct (estimated - see NOTE below)

Two bezel set round brilliant cut diamonds, clarity is "P1", colour is "H".

Dimensions (average) = 1.48mm(Dia) x 0.90mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 5.65 grams Total Gemstone Weight = 0.57ct Total Metal Weight = 5.54 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
