Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct rose gold & 18ct white gold, diamond set, multistone ring. Plain, narrow, half round, tapered band, measures 2.47mm width (at base) x 1.50mm depth, with curved underrail.

Feature, "solitaire style" ring design, with undecarriage set stones. Comprising, a raised white gold, double four claw setting to top, houses one round brilliant cut diamond, claw set. Below the central setting, a chinere contains one round brilliant cut diamond, rub-over sett, both sides. The extended shoulders, of the rose gold band, tapers up to pointed end terminations.



Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = N.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.

Dimensions = 5.07mm (average diameter) x 3.09mm (D-estimated)

Total Weight = 0.48st (astigated, see NOTE below)

Total Weight = 0.48ct (estimated - see NOTE below).

Two rub-over set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H", medium cut quality.

Dimensions = 1.30mm (average diameter) x 0.79mm (D-estimated)

Total Weight = 0.02ct (estimated - see NOTE below).

Total Item Weight = 3.82 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 3.72 grams (estimated)

NOTE: Limited germological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
