


## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand-assembled raised, 18ct yellow and white gold & gemset, multistone ring. Plain, narrow, low half round, tapered band, measures 2.18mm width (at base) x 1.20mm depth, with curved underrail.

Feature, "trilogy white gold" setting to top, with shoulder stones. Housing three Princess cut diamonds, claw set. The extended shoulders, of the yellow gold band, each shoulder contains four Princess cut diamonds, channel set, to both sides.





The ring contains;

One claw set Princess cut diamond, clarity is "Si", colour is "G", medium cut quality.

Dimensions = 3.38mm (L) x 3.38mm (W) x 2.40mm (D-estimated)

Total Weight = 0.22ct (estimated - see NOTE below).

Two claw set Princess cut diamonds, clarity is "S", colour is "G", medium cut quality.

Dimensions = 2.90mm (L) x 2.72mm (W) x 1.93mm (D-estimated)

Total Weight = 0.25ct (estimated - see NOTE below).

Eight channel set Princess cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.40mm (L) x 1.40mm (W) x 0.99mm (D-estimated)

Total Weight = 0.13ct (estimated - see NOTE below).

Total Item Weight = 2.84 grams, Total Gemstone Weight = 0.60ct, Total Metal Weight = 2.72 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
