Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold and rhodium plated, multistone ring, of cast construction.

Plain, wide, tapered band of 4.07mm width (at base) x 1.11mm depth with a hollow top and shoulders, open back settings, and a cut out underrail.

Feature four horizontal rows of seven round brilliant cut diamonds, spanning across the top of the band, varying in size, and channel set. The settings are secured between the tapering shoulders, of the plain and polished yellow gold band. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped '417 1.00 TDW MHJ' - acid tested as approximately 10 carat gold.

Ring size: U.

The ring contains:

Twenty Eight channel set round brilliant cut diamonds, clarity is "Si & P1 & P2 & P3" (mixed), colour is "H to J" (mixed).

Dimensions = 1.98mm(Dia) x 1.21mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 6.45 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 6.25 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
