Item 1

One, mixed metals, diamond set, multistone, pendant of hand-assembled construction.

Feature 'losenge' shaped pendant, with a central four claw setting, housing one round brilliant cut, claw set. There is one row of three round brilliant cut diamonds, to the top and bottom of the central setting, bead set. The pendant is finished with an articulated open pear shaped bail.

Pendant dimensions = 27.00mm (ave. length) x 11.41mm (ave. width) x 5.48mm (ave. depth).

Polished finish.

Stamped 'HK' - x-rayed as approximately 6ct.

The pendant contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G".

Dimensions = 4.53mm(L) x 4.52mm(W) x 2.53mm(D-estimated) x 1%(Girdle Thickness)

Total Weight = 0.32ct (estimated - see NOTE below)

Six bead set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to I" (mixed).

Dimensions (average) = 1.58mm(Dia) x 0.96mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 1.90 grams Total Gemstone Weight = 0.42ct Total Metal Weight = 1.82 grams (estimated)

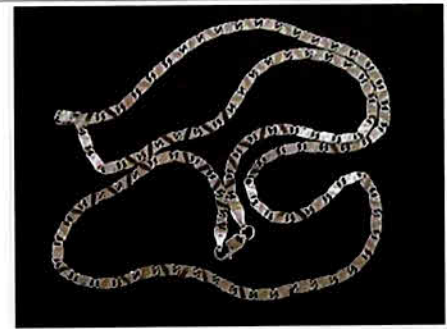
