## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 10ct yellow gold and 10ct white gold, multistone ring.

Plain, wide, tapered band of 14.29mm at top to 4.02mm in width (at base) x 1.24mm depth, with a curved and pierced, 'lattice' style underrail.

Feature central raised three row section, housing a total of twelve round brilliant cut diamonds, tapering in size, claw set. To each end and the outer rows house a total of twenty-six round brilliant cut diamonds, bead set. The shoulders of a two tone 'rippled' style.

Polished finish - stamped '10K 1.00 TDW michael hill' - acid tested as approximately 10 carat gold. Finger size is U.

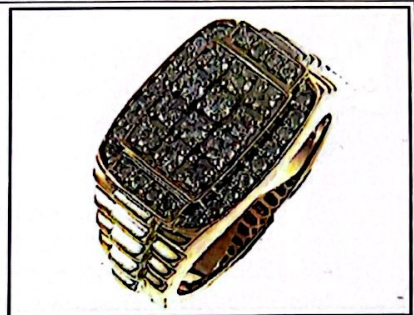
The ring contains:

- Twelve claw set round brilliant cut diamonds, clarity 'P2 & P3' (mixed), colour 'H'.  
Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (smallest)  
Dimensions = 2.65mm(Dia) x 1.62mm(D-estimated) x 2%(Girdle Thickness) (largest)  
Total Weight = 0.60ct (estimated - see NOTE below)
- Twenty Six bead set round brilliant cut diamonds, clarity 'P3', colour 'H'.  
Dimensions (average) = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 9.47 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 9.27 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
