One, hand-assembled, platinum, 'solitaire' design, diamond set ring.

Plain, narrow, tapered band of 2.53mm in width (at base) x 1.47mm depth.

Feature 'solitaire' style ring design, consisting of a six claw 'coronet' style setting, housing one round brilliant cut diamond, claw set. Secured to the top of the plain and polished band.

Polished finish.

Stamped '750 PLAT TC' - acid tested. Finger size is M.

The ring contains:

One claw set round brilliant cut diamond, clarity 'Si1', colour 'E'.
Dimensions = 5.20mm(L) x 5.16mm(W) x 3.12mm(D-estimated) x 3.5%(Girdle Thickness)
Total Weight = 0.51ct(estimated - see NOTE below)

Total Item Weight = 4.59 grams
Total Gemstone Weight = 0.51ct
Total Metal Weight = 4.49 grams (estimated)
