Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 14ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 1.62mm in width (at base) x 0.96mm depth, with hollow top and shoulders, and open back settings.

Feature central multi-claw setting, housing three round brilliant cut diamonds, tapering in size, shared claw set. Secured between the 'cross-over' style shoulders of the plain and polished band. Each shoulder having two round brilliant cut diamonds (smallest), channel set.

Polished finish.

Stamped '14K' - acid tested as 14 carat gold.

Finger size is J.

The ring contains:

- Seven claw set & channel set (mixed) round brilliant cut diamonds, clarity 'Si, P1, P2 & P3' (mixed), colour 'G to H' (mixed).
- Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 3.14 grams
Total Gemstone Weight = 0.18ct
Total Metal Weight = 3.11 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
