## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.96mm width (at base) x 1.03mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature cushion shaped top plate with a central four claw setting, housing one cushion shaped diamond, claw set. Surrounding is one row of sixteen round brilliant cut diamonds, bead set. The top plate is secured to the underrail, and in between the extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of eight round brilliant cut diamonds, bead set.



Polished finish.

Stamped '750 8K unknown makers mark' - acid tested as 18 carat gold.

Ring size: K.

The ring contains:

One claw set cushion cut diamond, clarity is "Si2", colour is "F".

Dimensions = 5.37mm(L) x 5.14mm(W) x 3.45mm(D-estimated) x 8%(Girdle Thickness)

Total Weight = 0.80ct (known weight - see NOTE below)

Thirty Two bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G".

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.35ct (estimated - see NOTE below)

Total Item Weight = 3.10 grams Total Gemstone Weight = 1.15ct Total Metal Weight = 2.87 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 7293093332 Dated: May 17, 2018. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 7293093332. No diamond certificate or paperwork was presented at the time of this valuation. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
