Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, flexible link necklet, of hand-assembled construction.

Feature open 'heart' shaped pendant, housing one row of twenty round brilliant cut diamonds, slightly graduating in size, largest to the points of the heart shape, claw set. The pendant is suspended with a 'trace' style link chain secured to the sides of the pendant. The chain is finished with a small bolt ring.

Chain dimensions = 45.00cm (ave. length) x 1.18mm (ave. width).

Pendant dimensions = 24.30mm (ave. length) x 21.60mm (ave. width) x 4.10mm (ave. depth).

Polished finish.

Stamped '750' - acid, tested as 18 carat gold.

The necklet contains:

Twenty claw set round brilliant cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "G".

Dimensions = 2.95mm(Dia) x 1.80mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.37mm(Dia) x 2.06mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 2.28ct (estimated - see NOTE below)

Total Item Weight = 5.82 grams Total Gemstone Weight = 2.28ct Total Metal Weight = 5.36 grams (estimated)
