Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 9ct yellow and white gold, diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.61mm width (at base) x 0.82mm depth, with cut-out underrail, open back shoulder settings, underneath.

Feature, solitaire style" ring design, with shoulder stones. Comprising, a raised white gold, rub-over setting, housing, one Princess cut diamond, rub-over set. The extended shoulders, of the band, tapers up to the top, Each shoulder contains four Princess cut diamonds, channel set, to both sides.

Polished finish, stamped "375, &? unreadable" - acid tested as 9 carat gold.

Finger size = L.

the ring contains; -

One rub-over set Princess cut diamond, clarity is "Si", colour is "G", medium cut quality.

Dimensions = 3.93mm (L) x 3.93mm (W) x 2.79mm (D-estimated)

Total Weight = 0.34ct (estimated - see NOTE below).

Eight channel set Princess cut diamonds, clarity is "VS & Si"(mixed), colour is "H to I"(mixed), medium cut quality.

Average dimensions = 1.70mm (L) x 1.70mm (W) x 1.21mm (D-estimated)

Total Weight = 0.16ct (estimated - see NOTE below).

Total Item Weight = 2.11 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.01 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
