### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, platinum, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, knife edge band of 1.68mm width (at base) x 1.79mm depth, with a curved underrail.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the knife-edge shoulders, of the plain and polished band.

Polished finish.

Stamped '22537318 TIFFANY & co. C PT950 .27CT' - acid tested as platinum.

Ring size: K.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs", colour is "F/G".

Dimensions = 4.16mm(L) x 4.15mm(W) x 2.45mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 3.39 grams

Total Gemstone Weight = 0.27ct

Total Metal Weight = 3.34 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The diamond has been inscribed on the kite facet with T & Co and H10170351. No diamond certificate or paperwork was presented at the time of this valuation. The ring has a stamp of Tiffany & Co upon - however, Tiffany in Melbourne will not assist with help in authenticating whether or not the ring is of their supply. Therefore, the below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
