## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand crafted, 18ct white gold, multistone, gem set ring. Plain, wide, ribbed band of 3.00mm in width (at base) x 0.89mm depth, with hollow top and shoulders, and open back settings.

Feature three central four claw settings, each housing one round brilliant cut diamond, tapering in size, claw set. Secured between the 'cross-over' and 'ribbed' style shoulders and setting sides of the plain and polished band.

Polished finish - unstamped - acid tested as 18 carat gold. Finger size is M+.

The ring contains:

Three claw set old cut diamonds, clarity 'Si & P1' (mixed), colour 'K, H to I' (mixed).

Dimensions = 3.10mm(Dia) x 2.20mm(D-estimated) (smallest)

Dimensions = 3.46mm(Dia) x 2.46mm(D-estimated) (largest)

Total Weight = 0.34ct (estimated - see NOTE below)

Twenty Four bead set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'H'.

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.22ct (estimated - see NOTE below)

Total Item Weight = 4.90 grams - Total Gemstone Weight = 0.56ct - Total Metal Weight = 4.79 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
