## Valuation for Traditional Retail Replacement

### Item 1

One, hand-assembled raised, 9ct yellow gold & 9ct white gold, diamond set, dress ring. Plain, wide, low half round, tapered band, measures 3.75mm width (at base) x 1.38mm depth, tapers up to 6.00mm width (at top), with cut-out underrail, open back to the setting, underneath.

Feature "dress style" ring design, comprising, a plain yellow gold band, with a raised white gold, brush finished, extended shoulders, housing one Princess cut diamond, to centre, rub-over set. The band tapers wide to the top, from both sides.

Polished finish, stamped "375 heart symbol .24" - acid tested as 9 carat gold.

Finger size = T.

The ring contains;

One rub-over set Princess cut diamond, clarity is "P1", colour is "H", medium cut quality.  
Dimensions = 3.54mm (L) x 3.54mm (W) x 2.51mm (D-estimated)  
Total Weight = 0.24ct (estimated - see NOTE below).

Total Item Weight = 7.40 grams, Total Gemstone Weight = 0.24ct, Total Metal Weight = 7.35 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
