## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, hand-assembled raised, 10ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 4.01mm combined basal width, x 1.30mm depth, with curved underrail.

Feature, "2pce ring set". Comprising, and engagement ring, a raised four claw setting, houses four princess cut diamond, grouped, claw set. The extended shoulders, tapers up both sides. Each shoulder contains five round brilliant cut diamond, bead set. The side band, contoured to fit, containing two round brilliant cut diamonds, claw set, one each side of the central setting.



Polished finish, stamped "10K MHJ" - acid tested both rings. Finger size = N1/2.

The ring set contains;

Four claw set Princess cut diamonds, clarity is "P1 to P2"(mixed), colour is "G to H"(mixed), medium cut quality.  
Dimensions = 2.20mm (L) x 2.20mm (W) x 1.56mm (D-estimated)  
Total Weight = 0.24ct (estimated - see NOTE below).

Twelve claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "G to I"(mixed), medium cut quality.  
Dimensions = 1.27mm (average diameter) x 0.77mm (D-estimated) (smallest)  
Dimensions = 2.04mm (average diameter) x 1.24mm (D-estimated) (largest)  
Total Weight = 0.24ct (estimated - see NOTE below).

Total Item Weight = 4.20 grams, Total Gemstone Weight = 0.48ct, Total Metal Weight = 4.10 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
