Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand-assembled raised, sterling silver & diamond set pendant/necklet.

Feature, "pear-shaped cluster" pendant/necklet. Comprising, a pear-shaped cluster, housing thirty two round brilliant cut diamonds, tapering sizes, illusion & claw set (mixed). An articulated bail to top, contains six round brilliant cut diamonds, claw set. Suspended from a flexible, wheat link, style chain, with a bolt ring clasp closure, attached one side.

Polished finish, stamped "925 XI" - acid tested as silver.

Pendant dimensions = 25.00mm (total length) x 11.76mm (width) x 6.15mm (depth).
Chain dimensions = 46.50cm (total length) x 1.11mm (width) x 1.11mm (depth).

The pendant/necklet contains:

Nine illusion claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.59mm (average diameter) x 0.97mm (D-estimated) (smallest)
Dimensions = 1.68mm (average diameter) x 1.02mm (D-estimated) (largest)
Total Weight = 0.16ct (estimated - see NOTE below).

Twenty Nine claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.06mm (average diameter) x 0.65mm (D-estimated) (smallest)
Dimensions = 1.49mm (average diameter) x 0.91mm (D-estimated) (largest)
Total Weight = 0.29ct (estimated - see NOTE below).

Total Item Weight = 2.70 grams, Total Gemstone Weight = 0.45ct, Total Metal Weight = 2.61 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar Pendant/necklet, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
