Valuation for Traditional Retail Insurance Replacement

Item 1

One, pair of lady's, hand-assembled raised, sterling silver & diamond set, pear-shaped, cluster style stud earrings.

Feature, "cluster stud earring". Each comprising, a pear-shaped cluster, housing thirty two round brilliant cut diamonds, illusion & bead set (mixed). Both with plain post & butterfly fittings attached.

Polished finish, stamped "925" (both earrings & butterflies) - acid tested as silver.

Earring dimensions = 13.54mm (length) x 10.26mm (width) x 6.61mm (depth).

The earrings contain:

Sixty Four claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.09mm (average diameter) x 0.66mm (D-estimated) (smallest)
Dimensions = 1.26mm (average diameter) x 0.77mm (D-estimated) (largest)
Total Weight = 0.45ct (estimated - see NOTE below).

Total Item Weight = 3.00 grams, Total Gemstone Weight = 0.45ct, Total Metal Weight = 2.91 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
