Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, raised 9ct white gold & diamond set, multistone ring, of cast construction. Plain, narrow, half round, tapered band, measures 2.12mm width (at base) x 1.60mm depth, with cut-out underrail, underneath.

Feature, "solitaire style" with shoulder stones. Comprising a raised four claw illusion setting, houses one round brilliant cut diamond, illusion claw set. The extended shoulders, of the band, tapers up to the top. Each shoulder contains seven round brilliant cut diamonds, channel set, both sides.

Polished finish, stamped "375" - acid tested as 9 carat gold. Finger size = Q.

The ring contains;

One illusion claw set round brilliant cut diamond, clarity is "Si", colour is "J", medium cut quality.

Dimensions = 3.45mm (Diameter) x 2.60mm (D-estimated)
Total Weight = 0.19ct (estimated - see NOTE below).

Seven channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "I to K" (mixed), medium cut quality.

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated)
Total Weight = 0.21ct estimated

Total Item Weight = 2.65 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 2.57 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
