Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.95mm width (at base) x 1.07mm depth, with hollow top and shoulders, open back settings, and a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is a square top plate, housing sixteen single cut diamonds, bead set. The top plate has a pierced decorative gallery and is secured between the extended and pointed shoulders. Rhodium plating to the setting areas.

Polished finish

Stamped '375 CG' - acid tested as 9 carat gold.

Ring size: K.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "H".

Dimensions = 3.50mm(Dia) x 2.14mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Sixteen bead set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 0.80mm(diameter) (smallest)

Dimensions = 0.90mm(diameter) (largest)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 1.80 grams Total Gemstone Weight = 0.22ct Total Metal Weight = 1.76 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
