Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, raised 9ct white gold & diamond set, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures 1.86mm width (at base) x 1.11mm depth, with curved underrail.

Feature, "single row" style, runs across the top of the band, housing thirteen round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up to the top, from both sides.

Polished finish, stamped "375, JP88" - acid tested as 9 carat gold.

Finger size = O.

The ring contains;

Thirteen claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated)
Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 1.81 grams, Total Gemstone Weight = 0.20ct, Total Metal Weight = 1.77 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
