Valuation for Traditional Retail Insurance Replacement

Item 1

One gents, hand finished raised, 10ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 3.99mm width (at base) x 0.80mm depth, with curved underrail.

Feature, "dress style" ring design. Comprising, a rectangular-shaped top. Four channel rows run across, housing twenty eight round brilliant cut diamonds, tapering sizes, all channel set. The extended shoulders, of the band, tapers up to the top, from both sides.

Polished finish, stamped "417, MHJ" - acid tested approximately 10 carat gold.

Finger size = T1/2.

The ring contains;

Twenty Eight channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 2.26mm (average diameter) x 1.38mm (D-estimated) (smallest)
Dimensions = 2.39mm (average diameter) x 1.46mm (D-estimated) (largest)
Total Weight = 1.00ct (estimated - see NOTE below).

Total Item Weight = 6.42 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 6.22 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
