Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 9ct yellow gold & diamond circular-shaped, drop style pendant.

Feature, "open circular" style pendant. Comprising, a raised railed, 5 x trilogy claw settings, alternate with five plain navette shaped, motifs around the circumference of the pendant. Suspended from an articulated v-shaped bail attached to top,

Polished finish, stamped "375, WB" - acid tested as 9 carat gold.

Pendant dimensions = 31mm (total length) 24.00mm (width) x 3.13mm (depth).

The pendant contains:

Fifteen claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.67mm (average diameter) x 1.02mm (D-estimated) (smallest)

Dimensions = 2.08mm (average diameter) x 1.27mm (D-estimated) (largest)

Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 1.76 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 1.71 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
