Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 9ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.57mm width (at base) x 1.20mm depth, with curved underrail.

Feature, "illusion solitaire style' with shoulder & undercarriage set stones. Comprising, a raised four claw setting to top, houses one round brilliant cut diamond, illusion claw set. The extended shoulders, of the band, taper up. each shoulder & undercarriage, contain a total of sixteen round brilliant cut diamonds, tapering sizes, claw set.



Polished finish, stamped "375, JP02" - acid tested as 9 carat gold.

Finger size = L.

One illusion claw set round brilliant cut diamond, clarity is "P2", colour is "H", medium cut quality.

Dimensions = 3.63mm (average diameter) x 2.21mm (D-estimated)

Total Weight = 0.18ct (estimated - see NOTE below).

Sixteen claw set round brilliant cut diamonds, clarity is "P1 & P2", colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.38mm (average diameter) x 0.84mm (D-estimated) (smallest)

Dimensions = 2.09mm (average diameter) x 1.27mm (D-estimated) (largest)

Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 2.49 grams, Total Gemstone Weight = 0.58ct, Total Metal Weight = 2.37 grams (estimated)

NOTE: Limited germological testing, inset. Due to setting constraints, the exact dimensions of the germstones cannot be ascertained. Therefore, weights of the germstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the germstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
