Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold, diamond set, multistone ring.

Plain, narrow, low half round, tapered band, measures 2.11mm width (at base) x 1.02mm depth, with curved underrail, open back setting, underneath.

Feature, "solitaire style" ring design, with shoulder stones. Comprising, a raised white gold six claw setting to top, houses one round brilliant cut diamond, claw set. The extended shoulders, of the yellow gold band, tapers up to the top, from both sides. Each shoulder contains, four round brilliant cut diamond, bead set, both sides.



Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = K1/2.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P1", colour is "J", medium cut quality.

Dimensions = 4.11mm (average diameter) x 2.51mm (D-estimated)

Total Weight = 0.25ct (estimated - see NOTE below).

Eight bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.

Dimensions = 1.44mm (average diameter) x 0.88mm (D-estimated)

Total Weight = 0.09ct (estimated - see NOTE below).

Total Item Weight = 3.70 grams, Total Gemstone Weight = 0.34ct, Total Metal Weight = 3.63 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
