Valuation for Traditional Retail Insurance Replacement

Item 1

One sterling silver, diamond set, necklet, of hand-assembled construction.

Feature round shape pendant, with a central round articulated illusion setting, housing one round brilliant cut diamond, illusion set. The illusion setting is within a 'tree' motif, surrounded by one row of forty-eight single cut diamonds, bead set. The top plate is supported with an open pierced gallery, in a 'scroll' pattern. The pendant is finished with a tapered bail. The pendant is suspended on a 'trace' style link chain, with a small bolt ring.

Chain dimensions = 47.00cm (ave. length) x 0.95mm (ave. width).

Pendant dimensions = 25.00mm (ave. length) x 19.50mm (ave. width) x 3.77mm (ave. depth).

Polished finish. Stamped '925 MHJ 0.19 TDW' - acid tested as sterling silver.

The necklet contains:

One illusion set round brilliant cut diamond, clarity is "Si2", colour is "H".

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.05ct (estimated - see NOTE below)

Forty Eight bead set single cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 0.75mm (diameter)

Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 3.67 grams Total Gemstone Weight = 0.19ct Total Metal Weight = 3.63 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
