Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, diamond set, multistone necklet, of hand-assembled

Feature one round illusion plate, housing one round brilliant cut diamond, illusion set. Surrounding is one row of eighteen single cut diamonds, bead set. The settings are enclosed with a domed and pierced decorative panel to the reverse. The pendant is finished with a tapered bail. The pendant is suspended from a filed curb link style chain. The chain is finished with a small bolt ring. Rhodium plating to the setting areas.



Chain dimensions = 45.00cm (ave. length) x 1.45mm (ave. width) x 0.76mm (ave. depth).

Pendant dimensions = 12.00mm (ave. length) x 7.20mm (ave. width) x 4.00mm (ave. depth).

Polished finish. Stamped '375 MW JP88' - acid tested as 9 carat gold.

The necklet contains:

One illusion set round brilliant cut diamond, clarity is "Si", colour is "J"

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.06ct (estimated - see NOTE below)

Eighteen claw set single cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to K" (mixed).

Dimensions (average) = 0.86mm (diameter)

Total Weight = 0.07ct (estimated - see NOTE below)

Total Item Weight = 3.09 grams Total Gemstone Weight = 0.13ct Total Metal Weight = 3.06 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
