Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct white gold, multistone ring set. The set comprising a 9ct white gold, diamond set engagement ring, with a matching 9ct white gold diamond set wedding ring. Each ring having a plain, narrow band with a combined basal width of 3.58mm x 1.54mm in depth.

The engagement ring has a central four claw setting, housing one oval cut and faceted topaz, claw set. Surrounded by sixteen round brilliant cut diamonds (smallest), claw set. Four claw base support, all secured between the extended shoulders of the plain and polished band. Each shoulder having seven round brilliant cut diamonds, largest tapering down in size, also claw set. The matching wedding ring having a single row spanning across the top of the plain and polished band, claw set with twenty round brilliant cut diamonds. The wedding ring sits alongside the engagement ring above. Polished finish - stamped '375 with diamond symbol' - acid tested as 9 carat gold. Finger size is R.



The ring contains:

One claw set mixed cut oval shape topaz, colour 'medium light blue'.

Dimensions = 7.10mm(L) x 5.04mm(W) x 3.02mm(D-estimated)

Total Weight = 0.80ct (estimated - see NOTE below)

Fourteen claw set round brilliant cut diamonds, clarity 'Vs, Si & P1' (mixed), colour 'G to I' (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.32ct (estimated - see NOTE below)

Thirty Six claw set round brilliant cut diamonds, clarity 'Vs, Si & P1' (mixed), colour 'G to I' (mixed).

Dimensions = 1.35mm to 1.40mm(Dias) x 0.82mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.43ct (estimated - see NOTE below)

Total Item Weight = 5.16 grams - Total Gemstone Weight = 1.55ct - Total Metal Weight = 4.85 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring set employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
