One, 18ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.53mm width (at base) x 1.12mm depth, with a curved underrail.

Feature central raised six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.



Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "J".

Dimensions = 3.54mm(Dia) x 2.20mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.17ct (estimated - see NOTE below)

Total Item Weight = 2.74 grams Total Gemstone Weight = 0.17ct Total Metal Weight = 2.71 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting.
